Due to limited port availability, some of our stops have been adjusted or replaced. Our stop in **Hilo, Hawaii** on **January 11** has been replaced with **Kahului, Maui, Hawaii**. The stop in **Kahului, Maui** on **January 12** has been replaced with **Honolulu, Oahu, Hawaii**. On **January 13**, our visit to **Honolulu, Oahu** has been changed to **Nawiliwili, Kauai, Hawaii**, and on **January 14**, our stop in **Nawiliwili, Kauai** has been replaced with **Kailua-Kona, Hawaii**.

We will depart **Bangkok, Thailand** at **10 PM on March 19** and enjoy a relaxing day at sea on **March 20**.

Our stop in **Hitachinaka, Japan** has been replaced with **Oarai, Japan** on **May 1**. Additionally, our stops in **Juneau and Sitka, Alaska**, have been swapped, we will now visit **Juneau on May 12** and **Sitka on May 13**.

On **June 13**, our stop in **Baltimore, United States** has been replaced with **New York, United States**. On **June 14**, our stop in **Philadelphia, United States** has been replaced with **Newport, United States**, followed by a scenic cruise through the **Cape Cod Canal**. Additionally, our stop in **New York** has been replaced with **Boston, United States on June 15**.
