We hope this message finds you well and looking forward to sailing on the **Azamara Journey®** departing on **May 21<sup>st</sup>, 2026.** We are writing to inform you of an important change to your itinerary.

Due to changes in the Formula 1 calendar, the Monaco Grand Prix 2026 will now be taking place on **June 7th** and will no longer be part of our itinerary. Although the itinerary remains the same, the updated schedule unfortunately will not allow our guests to experience the Grand Prix as originally planned. We understand the inconvenience and we apologize for the disruption that this modification may cause to your travel plans. We are dedicated to assisting you in finding alternative solutions to suit your preferences.

## Considering the impact of this modification, we are offering the following options

# Option 1: Remain on the Cruise

We hope to welcome you onboard your originally selected cruise. If you choose to join us as planned, please note that the itinerary will no longer coincide with the new Grand Prix dates.

In addition, you will receive an Onboard Credit (OBC) as follows:

- \$25 OBC per stateroom for Interior to Veranda Plus stateroom categories
- \$50 OBC per stateroom for Suites

The above OBC is in addition to any others you may have included in your current reservation.

# Option 2: Lift and Shift

Lift and Shift your booking to **our suggested Azamara cruise.** This suggested itinerary includes a stop in Villefranche, France, with excursions to the Grand Prix on its new scheduled date.
