

<u>CITY PICKUP TRONCHETTO LAST PEOPLE MOVER STATION (FOR GUEST WHO HAVE PURCHASED THIS TRANSFER):</u>

- An Azamara Cruises representative will meet guests at 12:00 p.m., 12:30 p.m., and 1:30 p.m. at the Tronchetto People Mover Station.
- For Independent Travelers we recommend using the bus or People Mover to reach the

Tronchetto People Mover Station from the city center. Transfer will be available for purchase on the day of sailing, subject to space availability. Please note that land taxis may not always be readily available.



NEW VENICE ACCESS FEE:

Beginning April 2025, the City of Venice has introduced a mandatory Access Fee for occasional visitors entering the historic center on designated high-traffic days between 8:30 a.m. and 4:00 p.m. Please take a moment to review the guidelines below:

Access Fee Days

The specific days when the fee applies are published in the official calendar, which can be found at <u>Venice Calendar for Access Fee.</u> where you can also follow the instructions to process the payment, if required.

The information below applies only if your arrival or stay falls on dates when the Access Fee is in effect. If your travel dates do not fall within the designated Access Fee period, this information will not apply to your visit.

Even if you are exempt from paying the Venice Access Fee, you are still required to register in advance. All visitors must obtain a QR code as proof of registration, regardless of whether a fee applies.

• If Venice is a Port of Call (Transit Day)

No action is required on your part. Azamara Cruises has already arranged this for you to ensure a seamless visit to Venice. The covered areas are: All of Venice's historic center, such as the districts of San Marco, Cannaregio, Castello, Dorsoduro, San Polo, and Santa Croce.

• If Venice is your Embarkation or Disembarkation Port

If you are visiting Venice on this day, you must obtain and pay for an individual access pass.

• <u>Pre/Post Cruise Stays in Venice</u>

Azamara will not cover the Venice Access Fee for guests staying in Venice before or after the cruise. However, if you are staying overnight at a Venice hotel and have paid the local tourist tax, you are exempt from the fee.

After payment, please retain your proof of payment or exemption with you during your visit, as it may be requested by authorized personnel.
